1. INTSHAYELELO

Umthetho okhuthaza ukufikelela kulwazi uAct No 2 ka 2000 ("Act"), inika uphuhliso kwilungelo lomgaqo siseko lokufikelela kulo naluphina ulwazi olufumaneka kulo naliphina iqumrhu labucala kwanelikarhulumente, lwazi olo olufunekayo kuphuhliso okanye ukhuseleko lwawo nawaphina amalungelo. LeAct ibeka ngokucacileyo imigaqo enxulumene neso sicelo.

Umqolo wesithoba we Act, kananjalo unika ingqwalasela yokuba la malungelo okufikelela kulwazi ahambe nemimiselo ethile, nemida engenakutsiywa enjengale:

- Ukukhuseleka kweemfihlelo okulilungelo
- Ukugcinwa ngokufihlakeleyo kwenkcukacha zezothengo
- Ukuphatha okulungileyo nokupheleleyo

USection 14 we Act uyawanyanzelisa amaQumrhu kawonke-wonke ukuba adibanise umqulu wengcaciso onjengalo, oyakuthi uncede abantu ukuze bafumane imvume yokufikelela kulwazi olukulomaQumrhu, kwaye uyayichaza imigaqo lo mqulu ekufuneka uyilandele.

Injongo yalengcaciso kukwazisa abantu indlela zokufikelela kwirekhodi ezikwa Petroleum Agency, kube kunika uphuhliso kuSection 14 we Act.

2. ISIGUNYAZISO SE PETROLEUM AGENCY

Isigunyaziso sePetroleum Agency sinamabakala agunyaziswe kwisiyalelo soMphathiswa (Ministerial Directive Schedule 3) somhla we 16 April 1999 kwiWhite Paper ye Energy Policy ka 1998, kwi Mineral and Petroleum Resource Development Act No 28 ka 2002 (MPRDA) (section 70), nakwi Memorandum neArticles of Associations ze Petroleum Agency.

I MPRDA iqale ukusebenza ngomhla wokuqala kuMay 2004, kwaye ibandakanya ukunika imvume kuMphathiswa weZimbiwa naMandla ukuba amisele iqumrhu likarhulumente elizakujongana nemisebenzi ethile emalunga nokulawulwa kwamalungelo okukhangelwa nokuveliswa kwe oil negesi. IPetroleum Agency yamiselwa nge 18 June 2004, kwaye isebenzela ukuqinisekisa ukuba ikulungele ukuphumeza ummiselo wayo ngokwe MPRDA.

6. INDLELA ETHI ILANDELWE KWIZICELO ZOLWAZI

Step 1: Indlela ethi ilandelwe yokufakwa kwesicelo

Lowo ufaka isicelo kufuneka azalise ifomu (Form A) edityaniswe kulomqulu, ayingenise ngesandla okanye ayiposele kwidilesi eyenzelwe oko njengoko kubhaliwe kumhlathi wesine ongentla.

Imali engange R35.00 kufuneka ihambe nesicelo eso solwazi. Le mali ithi ihlawulwe nge cheque okanye ngenkozo (xa isicelo siziswe ngesandla).

Step 2: Isiqinisekiso nesivumo

Igosa loLwazi lithi lamkele kwaye liqinisekise isicelo eso ukwenzela ukuba libone ukuba ulwazi olo luyafumaneka na kwi nkampani. Isicelo eso sithi ke samkelwe, sikhatywe, okanye sidluliselwe kwabo banelungelo lokugcina ulwazi olo. Lowo ufake isicelo uye anikwe isivumo (acknowledgement) esiqinisekisa ubume besicelo eso.

Step 3: Ukuqwalaselwa kolwazi

Ukuba isicelo sithe samkelwa, iPetroleum Agency ithi idibanise ilungise ulwazi olo, ze ibale indleko ezifanelekileyo. Indleko zibalwa ngokomhlathi wesixhenxe wesi sazisi ongzantsi.

Step 4: Isaziso sokugqibela

Lowo ufake isicelo uthi aziswe ngokugqitywa kwesicelo eso, kwanemali ekufuneka ihlawulwe kwaPetroleum Agency.

Step 5: Intlawulo nonikezelo lwe Miqulu

Emva kokuba intlawulo echazwe ku Step 4 ifunyenwe, (kulandelwe indlela emiselweyo eku **Step 1**), ulwazi olo luthi lunikezelwe kulowo ebefake isicelo.

Qaphela

Ifomu ekhethiweyo kufuneka igcwaliswe ngenkcukacha ezaneleyo ukwenzela ukuba iGosa loLwazi likwazi ukubona:

- Irekhodi okanye iirekhodi zezicelo;
- Isazisi salowo ufake isicelo;
- Yeyiphi ifomu yokufikelela efunekayo, ukuba isicelo siphumelele; kunye ne
- Dilesi yeposi okanye inombolo yefax yalowo ufake isicelo.

Lowo ufake isicelo kufuneka achaze ukuba ulwazi olo ulufunela ukusebenzisa okanye kukhusela ilungelo, kwaye achaze ngokucacileyo ubume belungelo elo elizakusetyenziswa okanye elikhuselwayo. Ukwangeza, lowo ufake isicelo kufuneka achaze ngokucacileyo ukuba kutheni kufuneka irekhodi leyo ukuze kusetyenziswe okanye kukhuselwe ilungelo elo.

I Agency iyakuthi isinike ingqwalasela isicelo eso kwisithuba sentsuku ezingamashumi amathathu, ngaphandle kokuba lowo ufake isicelo ube nezicelo ezikhethekileyo, ezinokuthi zanelise iGosa loLwazi ngokuba imeko ezithile

7. INTLAWULO YOKUFUMANA IREKHODI EPETROLEUM AGENCY

IGosa loLwazi kufuneka lazise lowo ufake isicelo (ngaphandle kofake isicelo sobuqu bakhe) ngokomyalelo, oyalela lowo ofake isicelo ukuba ahlawule indleko ezibekiweyo (ukuba zikhona) phambi kokuba isicelo eso siqwalaselwe.

IGosa loLwazi liyakuthi licele lowo ufake isicelo ukuba ahlawule ngaphambili inxalenye yemali yokufumana irekhodi leyo, mali leyo ebizakuhlululwa xa isicelo siphunyeziwe. Oku kuyakwenziwa xa isicelo serekhodi nokulungiswa kwaso, kudibene nokusifaka kwifomu eceliweyo, sithatha ixesha elingaphezulu kwelo limiselweyo kumgaqo woko.

 - Inkcukacha ezithe zachazwa phantsi kokuthembana kwalomntu ne Petroleum Agency, xa ukuchazwa kwazo kunokubeka lomntu kwimo engentle kwingxoxo okanye ukhuphiswano kubumo bentengo.
- (3) Ukhuseleko olugunyazisiweyo lwenkcukacha ezifihlakeleyo zabantu ukuba zikhuseleka yimiqathango yesivumelwano;
- (4) Ukhuseleko olugunyazisiweyo lokukhuseleka kwabantu nokukhuselwa kwempahla (property) zabo;
- (5) Ukhuseleko olugunyazisiweyo lwerekhodi, ezingabonwa njengezabucala ezibalulekileyo kwinkqubo zomthetho;
- (6) Ubume bezimali nentengo be Agency, obunokubandakanya:
 - Imfihlelo zorhwebo zePetroleum Agency;
 - Inkcukacha zezimali, zobume bentengo, nezenzululwazi ezinokubangela umonakalo kwezezimali nakubume bentengo be Petroleum Agency;

- Inkcukacha ekunokuthi ukuchazwa kwazo kubeke iPetroleum Agency esichengeni kwingxoxo okanye ukhuphiswano ngokobume bentengo;
 - Inkqubo yecomputer yePetroleum Agency, ekhuselwe ngamalungelo okuyishicilela;
- (7) Xa ukuchazwa kwenkcukacha zophando zequmrhu okanye umntu wesithathu kungabangela ukuvezwa kwequmrhu elo, umphandi lowo angabeka uphando esichengeni.
